## **HEALTH & SAFETY/BANNED ITEMS**

(To be completed in association with site rentals for Maleny Agricultural Show)

The Sunshine Coast Regional Council and Maleny Show Society Inc. (encompassing Maleny Showgrounds) undertake to ensure that the premises are safe and without risks to health as far as is practicable.

To ensure this safety, Council and the Show Society expect any persons other than Council or Show Society employees will:

- a. Act in a manner that does not endanger the health and safety of any other person at the showground.
- b. Not fail to carry out a safety direction that is given to the person by the Council/Committee for the showground.
- c. Will not wilfully or recklessly interfere with anything provided in the interests of health and safety at the showground.

In particular, the Electrical Safety Regulation 2002, Part 5, Division 5, will apply to electrical equipment. This includes, but is not restricted to:

- i. All electrical equipment will be tested and tagged in accordance with AS3760 this includes extension leads.
- ii. Extension leads will be tagged with the owner's name.
- iii. Portable electrical equipment is double insulated and earth leakage protected.
- iv. All flexible and extension leads must be supported at least two metres above ground.

#### FAILURE TO COMPLY WITH THE ABOVE MAY LEAD TO EVICTION FROM THE SHOWGROUND.

### List of **BANNED ITEMS** at the Maleny Agricultural Show:

The following items have been banned and you must acknowledge that you will not be bringing any of them to the show:

- + Drug related goods (including cocaine kits, bongs etc)
- + Explicit and hardcore t-shirts
- + Fake cigarettes
- + Fireworks-crackers
- + Fuel type fire lighters (zippo)
- + Horns and trumpets
- Knives (including pen knives)
- Laser Pointers
- + Metal and wooden Martial Art Nunchakas
- Playing Cards (nude or lurid)
- Pressure Pack Snow
- + Pressure Pack Fart Gas
- + Silly String
- + Stink Bombs
- + Bouncing Beans
- + Shang-hi/sling shots
- + Bomb Bags
- + Fire Wallets
- + Water Bomb

- + Toy Guns <u>are acceptable</u>, however the following <u>are not</u>:-
- Ball Bearing Guns
- + Eight Shot Caps
  - + Pellet Guns
- + Pop Downs (Throw Downs)
- + Potato Guns
- + Replica Guns (bullet type)
- + Roll Caps
- + Strip Caps
- + Water Pistols over 150mm (6")
- + Samurai Swords, English Swords and Fencing Swords are to be sold in **Sealed Packages** by <u>Licensed Traders ONLY</u>.
