2nd and 3rd prizes awarded only if more than 2 entries.

JUNIOR PRIZE MONEY: 1st \$6, 2nd \$4, 3rd \$2.

Prize money **must** be collected on **show days, Friday 31st May and Saturday 1st June** from the Show Office.

Exhibitors may sell goods on commission basis of 15% to Maleny Show Society.

Exhibitors are asked to stipulate their own price and attach readable price tags to the exhibits for sale.

Entries exhibited in previous Maleny Agricultural Show will be ineligible.

Entries must not have won a prize at any other competition.

Display space of entries will be limited, and at the discretion of the Stewards

NO work allowed to compete in more than ONE class.
